Training Program



The LPA Training Program was developed and implemented jointly by the Louisiana Department of Transportation and Development (DOTD), the Federal Highway Administration (FHWA) Louisiana Division, and the Louisiana Local Technical Assistance Program (LTAP).



Why Take the LPA Training?

The main objective of the LPA Training Program is to enhance the efficiency of local transportation projects that rely on state and federal funding.

The program supports local agency personnel by helping them understand and implement the requirements associated with these funding sources.

The LPA Qualification Program consists of two training classes;

LPA Qualification Core Training &

LPA Construction, Engineering, and Inspection
(CE&I)

LPA Qualification Core Training

This training is required by DOTD for all LPA

Responsible Charge project sponsors and for every consultant working on LPA projects receiving federal or state funding through DOTD. This training is required every five years. This training is recommended for administrative and financial managers with responsibility for: processing engineer and contractor invoices, submittal of reimbursement requests, as well as maintaining required documentation. It is also recommended for elected officials, MPO personnel, or anyone that will explain and/or be involved with a LPA project.

LPA Construction, Engineering, and Inspection (CE&I)

This training is now a <u>required</u> certification for the consultant **CE&I Project Engineer** performing CE&I services <u>every 2 years</u>, regardless of whether or not it is a LPA project.

LPA Qualification Core Training

13 PDHs (2-Day Class)

This class is required for all project sponsors and their consultants to be qualified to participate in the state and federal programs on future transportation projects. Administrative and financial managers with responsibility for processing engineer and contractor invoices and submittal of reimbursement requests as well as maintaining required documentation are recommended to attend.
