The meeting began with an ice breaker reception on Monday night (March 4), continued for two full days on Tuesday and Wednesday (March 5-6), and ended at noon on Thursday March 7; (program attached). The following is a summary of discussions, decisions and action items.

Introduction & Review of Meeting Goals

- The consortium budget and expenditures were reviewed.
- Last Quarterly Report provided to members (attached).
- The pooled fund commitments were reviewed (summary of commitments attached).
 - o No funds from Tennessee or Kentucky received.
- Meeting agenda and goals were discussed.

Review of STC Project Database & Website

- Project Website
 - o Usage of the database has been minimal, per below:

- Project Database
 - Current process to manage the information in the STC project database was reviewed as noted in the below bullets:
 - The TRID/RIP database will be used to maintain the STC database by LTRC staff search.
 - Each state will provide LTRC with the appropriate search organization title to search RIP to obtain project information.
 - Each state will compare the current information in the database to the current information in RIP to determine if any projects are missing.
 - Each state will supply LTRC with missing projects.
 - LTRC will search RIP quarterly to add new project to the database from each state.
 - LTRC will solicit completed projects from each state on a quarterly basis.

- o Discussion ensued on how this process has not worked:
 - Each member was provided with project data from their programs in the database.
 - LTRC manual search of RIP database was not providing accurate state DOT sponsored projects.
 - Response from states to confirm state projects were inconsistent among members.
 - LTRC staff will no longer make attempts to manually download project data.
 - A motion by LTRC to archive data as time specific and discontinue active updates was discussed and deferred.
- Action items include:
 - LTRC will pursue automatic entry from RIP into database similar to process used by RPM database. Tools will be investigated.
 - Report to members on outcome of this automatic entry will be made at July meeting in Baton Rouge.

Collaboration Opportunities

- Timber Bridge Inspection Collaboration:
 - o LTRC updated members on current activities with pilot states: Louisiana, Alabama, North Carolina, & Georgia.
 - o Project demonstration and data collection should be complete by the end of the summer 2013.
- Discussion was held on potential pooled fund research projects:
 - o Load Capacity/Rating of Timber Bridge Utilizing Inspection Tools
 - Louisiana would be lead state and anticipates conducting the research in-house.
 - Mutual interest was determined
 - Louisiana to develop solicitation document with background information to submit to member states for consideration of commitment.
 - o X-Ray Diffraction for Reactive Aggregates:
 - GDOT is to edit the research needs statement and follow up with states expressing interest.
 - Evaluating the Performance of Guardrail Systems Installed by Driving through Asphalt Layers:
 - GDOT is to discuss this with a Georgia university and look into a first-round, in-state study, before a TPF study is considered.
